



Specific Terms And Conditions for Prepaid Automated Bonus Top-ups (‘ChinaSaver\$22’, ‘MyanmarSaver\$23’, ‘LocalSaver\$18’)

1. Definitions

“General Terms” refers to Singapore Telecommunications Limited's Terms and Conditions of Service – General, as may be amended from time to time, and which is available for inspection at <http://www1.singtel.com/terms-general.html>.

“Prepaid Bonus Top-ups” means each of ChinaSaver\$22, MyanmarSaver\$23, LOCALSAVER\$18.

“Prepaid Bonus Top-up Accounts” means the bonus accounts of each of the Prepaid Bonus Top-Ups.

“Specific Terms” refers to Singapore Telecommunications Limited's Specific Terms and Conditions for Singtel Mobile, as may be amended from time to time, and which is available for inspection at <http://info.singtel.com/terms-Mobile>.

“Singtel Mobile” refers to Singtel Mobile Singapore Pte Ltd (CRN: 201012456C).

“User” refers to a customer who holds a pre-paid account with Singtel Mobile subject to the relevant terms and conditions of use of the applicable pre-paid card.

Words and expressions used in these Terms and Conditions shall have the same meaning as defined in the General Terms and/or the Specific Terms unless the context otherwise requires.

The headings or titles to the clauses in these Terms and Conditions are for reference only and shall not be referred to or relied upon in the construction of any provision of these Terms and Conditions.

2. Prepaid Automated Bonus Top-ups

2.1 Automated Bonus Top-ups for selected Prepaid Bonus Top-up Accounts may only be activated through Singtel hi!App. The Prepaid Bonus Top-up Accounts activated for Automated Bonus Top-ups will be automatically renewed upon expiry every 30 days unless automatic renewal is terminated by User through the Singtel hi!App. User must authorise a recurring credit or debit card deduction on the Singtel hi!App for payment of the Automated Bonus Top-up, which deduction will take place every 30 days.

2.2 Usage of the Prepaid Bonus Top-up Accounts will continue to be subject to the Terms & Conditions For Prepaid Bonus Top-ups, available at: www.singtel.com/prepaid.

3. General

3.1 Singtel Mobile may at its discretion and/or terminate, suspend in whole or in part Automated Bonus Top-ups without prior notice and without any liability.

3.2 Users are solely responsible for their use of the Automated Bonus Top-ups. Singtel Mobile shall not be liable in any way to any User or any other person for any losses or damages of any kind, including but not limited to direct, indirect, incidental, consequential, special or punitive damages arising out of or in connection with the use of the Automated Bonus Top-ups.

3.3 Each User agrees to fully and effectively indemnify, defend and hold harmless Singtel Mobile from and against any and all rights, demands, claims, causes of action, losses, damages, costs and expenses whatsoever that the User may have, or which may arise, whether in whole or in part, and whether directly or indirectly, due to or arising out of the use of the Automated Bonus Top-ups.
